Re: Endorsement of H.R 593 / S. 135: *The Coronavirus Mental Health and Addiction Assistance Act of 2021*

Dear Speaker Pelosi and Leaders McCarthy, Schumer and McConnell:

We, the undersigned national behavioral health and health care professional organizations, appreciate the action taken by Congress during the 116th Congress to address the unprecedented health and economic effects of the COVID-19 pandemic.

As you consider next steps, including President Biden's set of proposals, we strongly urge you to include the text of H.R. 593 / S. 135, *the Coronavirus Mental Health and Addiction Assistance Act of 2021*, as a component of the behavioral health provisions of any upcoming legislative package.

H.R. 593 (sponsored by Representatives Tim Ryan and John Katko) and S. 135 (sponsored by Senators Amy Klobuchar, Todd Young and Chris Van Hollen) is a critical bipartisan bill that authorizes \$100 million to initiate or expand programs offering mental health and substance use disorder services in response to the pandemic.

The Coronavirus Mental Health and Addiction Assistance Act of 2021 was drafted to initiate, expand or sustain programs that provide professional mental health and substance use disorder counseling. The bill also provides much-needed SAMHSA funding for support groups, helplines, telehealth and other services needed now and will continue to be needed in the aftermath of the COVID-19 pandemic.

We call your attention to H.R. 593 / S. 135 because this bill provides important funding, and a noteworthy list of eligible grantees and authorized activities that will unquestionably make a positive difference for those suffering from behavioral health concerns, including substance use disorders, that for many have been exacerbated by the pandemic and economic collapse. ***This bill is especially needed to provide support for the smaller, community groups and for the nonprofit organizations that have not had***

access to SAMHSA resources despite continuing to provide services throughout the pandemic and economic crisis.

Many individuals and families in this country are grappling with mental health conditions and addictions, and it is critical that they find the care they need, particularly now. H.R. 593 / S. 135 will expand access to vitally important programs and treatment. We urge inclusion of the text of the *Coronavirus Mental Health and Addiction Assistance Act of 2021* in the next legislative vehicle to address the pandemic.
