FAAPP Application Guide (2027)

Last updated: February 23, 2026

Description

THE AAPP FELLOW PROGRAM IS INTENDED TO:

- Grant recognition to individuals demonstrating excellence in advancing the practice of psychiatric pharmacy.
- Promote public awareness of pharmacists who have distinguished themselves in advancing the mission and goals of AAPP.

RECEIVING THE FELLOW DESIGNATION MEANS THAT THE FELLOW HAS:

1. Been a member of AAPP for a minimum of 10 years.
2. Contributed significantly to AAPP.
3. Served as an expert in the field of psychiatric pharmacy.
4. Helped advance the specialty through leadership in education, research, and/or advocacy.

APPLICANTS MUST MEET FOUR CRITERIA:

Applicants can verify that they meet criterion 1 and 2 through the “My Fellow Program Transcript” located under My AAPP at aapp.org.

1. **Membership:** Applicant is a current member who has been an Active Category member in AAPP for 10 or more years (not necessarily consecutive). Applicants must have been an active category member the year before you applied, and the year you are applying does not count within the 10-year minimum requirement. AAPP membership years run from July 1 through the following June 30 and membership will be verified by staff. Individuals awarded Fellowship must maintain membership in AAPP to use the credentials FAAPP.
2. **Service to AAPP:** Applicant has contributed through AAPP volunteer service on par with 7 years of standing committee service, not inclusive of leadership assignments, or 5 to 6 years of standing committee service including at least 1 leadership role (e.g., member of the Board of Directors, committee chair, etc). This criterion will be verified by staff.
3. **Expertise:** Applicant is an expert who is a current BCPP, or who demonstrates knowledge, experience and expertise that is comparable with the BCPP. Those seeking fellowship without the BCPP must complete an essay that will be evaluated by a panel for comparability with the BCPP.
4. **Leadership:** Applicant is a leader in the specialty who demonstrates their leadership by contributing to Education, Research, and Advocacy in the specialty.

FAAPP Frequently Asked Questions

Will there be any application submission extensions?

No, with a 3-month application window, extensions will not be allowed for any reason, including technical, health, or emergency issues in the last week of the window. The deadline is 10/1/26.

Does the application have to be completed in one sitting?

No, you do not have to complete the application in one sitting. As you complete the online application (on or before 10/1), remember to **save frequently** by clicking save at the bottom of the application. You can maintain the status of the application as Not Yet Final (at the bottom of the application) until you are ready to submit at which time you would mark status of the application as Final. Prior to uploading the PDF of any supporting documents, you are encouraged to save your application without the file to ensure all fields are saved and then edit the application again to upload the PDF.

What if I believe there is an error in my AAPP membership and service transcript?

As noted in the transcript disclosures, AAPP works hard to maintain accurate member records. However, we acknowledge that some service was not tracked until recent years and service before 2003 was not digitized. If you meet the 10-year membership requirement and the 35-point threshold for AAPP service, do not contact the office unless you have an important business reason to request a review of your record. If you do not meet the threshold and believe items are missing, please contact the office at info@aapp.org and advise on what you specifically believe might be missing. Being specific on the type of service/committee and year(s) would be helpful in our research. Research can generally be conducted by AAPP staff within 10-14 business days.

What membership years count towards the 10-year membership requirement?

Membership years that fall into the "Active Member" category are included in the 10-year requirement. Membership years designated as "student" or "resident" do not count toward this requirement. This aligns with the goals of the fellowship being to grant recognition to individuals demonstrating excellence in advancing the practice of psychiatric pharmacy which is believed to be best accomplished when employed as a practicing psychiatric pharmacist in your chosen career path(s).

Why are there no point values assigned to elements requested to prove the leadership criteria (criteria 4)?

Assuming diversity in applicant pool, the first three to four years of FAAPP applicants will allow AAPP to conduct a standard setting process and establish cut-off scores for the various elements and overall awarding of the FAAPP credential.

If I hold an active BCPP credential, do I need to write a narrative essay for the expertise criteria?

No. Those members with an active BCPP credential, or those that held the BCPP credential at the time of retirement, satisfy the expertise criteria. AAPP believes the Board-Certified Psychiatric Pharmacist credential represents the gold standard and has public statements and organizational documents and papers that support this. Given its emphasis on patient care and the rigor of the examination and recertification process (education or retesting), this credential is believed to be the best universal, consistent measure of expertise, especially given the varied practices/employment of psychiatric pharmacists.

Can the same activities be counted in multiple categories of the leadership section of the application?

Maybe. Presentations (platform and/or poster) that are presented as an “encore presentation” may be listed more than once, but it should be clear that it was given as an “encore presentation” based on the meeting name and location indicating a second audience.

Can student and/or resident activities and accomplishments be included in the leadership section (criteria 4) of the application.

No. The goal of the Fellowship program is to grant recognition to individuals demonstrating excellence in advancing the practice of psychiatric pharmacy. This recognition is most impactful when awarded to those members actively practicing as psychiatric pharmacists in their chosen career paths. While the experiences and achievements of student and resident activities are highly valuable, the focus of the Fellowship program is on accomplishments made independently in professional roles.

What type of supporting evidence should be submitted for AAPP Fellow Application?

After each activity/topic within the “Leadership” portion of the application, text fields have been included to enter supporting evidence supporting the number you selected for that activity. Each text field contains information on the type of supporting evidence that should be submitted in these fields.

EXAMPLE:

The applicant responded that they had created one (1) national or international educational presentation. In the text field they should list the title of the presentation, where the presentation was given (conference name and location), and the date of the presentation as follows:

Pharmacologic Management of Insomnia with Sleep Apnea. Presented at the College of Psychiatric and Neurologic Pharmacists Annual Meeting. April 2021.

If in completing the online application, I have listed supporting evidence as required in the specified text fields, do I also need to include this evidence in the uploaded document?

No. If supporting evidence is listed in the text fields provided, it does not need to be resubmitted within the uploaded document. The uploaded PDF should include any supporting evidence that cannot be captured in the text field (e.g., photos, files, etc.). When evidence is included in the PDF, the applicant should add content describing which criterion the evidence relates to for the benefit of the reviewers. The uploaded document, including the CV, will only be used if clarification is needed for responses provided in the online application. The applicant should consider responses submitted throughout the online application to be their primary responses for consideration of fellowship.

Is AAPP limiting the size of fellow classes annually?

At present, AAPP is not limiting the size of each class but will monitor class sizes and criteria on an ongoing basis to ensure the FAAPP is rigorous, meaningful, fair, and valid.

Do applicants need to be certain they can attend the AAPP Annual Meeting to be installed as a Fellow before they apply for consideration as a Fellow?

Individuals selected as Fellows are highly encouraged to attend the AAPP Annual Meeting but are not mandated to attend. Fellows will be officially installed during a brief certificate ceremony following a Monday AM general session of the Annual Meeting. A dinner will be hosted on Monday evening where each Fellow will be recognized and accept their Fellow desktop award. A professional photographer will capture individual and group photos during the dinner celebration only.

General Information

- Applications can only be submitted [online](#).
- The FAAPP application will open July 1 and close for submissions on October 1 at close of business.
- Decisions will be announced no later than January of 2026 and Fellows will be installed during AAPP 2027 on April 5 in Louisville, KY.
- The applicant should consider responses submitted throughout the online application to be their primary responses for consideration of fellowship.
- AAPP is previously known as CPNP and this fellow program encompasses all CPNP and AAPP service.
- Psychiatric pharmacy can be globally defined by the exam content outline (ECO) of the [Board Certification in Psychiatric Pharmacy \(BCPP\) exam](#). Items submitted for consideration on this application should be related to psychiatric pharmacy and aligned with areas specified in the BCPP ECO.
- The applicant must agree to an Honor Code consisting of:
 - I affirm that the information I am providing in my application for FAAPP is true, honest, accurate, and thorough. I affirm that I will not share my application with colleagues pursuing the FAAPP credential now or in the future and that I accept the decisions of AAPP regarding my selection as an FAAPP.
- The applicant must agree to AAPP's Code of Conduct.
- Members of the Board of Directors and Fellowship Committee are not eligible to apply for AAPP Fellowship.

Application Information/Tips

- Applicants who do not submit a full application, fail to follow instructions, and/or indicate "refer to CV" in the supporting evidence fields will immediately be disqualified and not evaluated/scored by the Fellowship Committee.
- The applicant should take time to thoroughly complete this application. It is in the applicant's best interest to respond to as many questions as appropriate and to provide appropriate documentation in order to ensure a fair review. An applicant's entire career, their

accomplishments, and activities related to that career, should all be considered and included when completing and submitting the application.

- Applications are to be completed online in the application [form](#) provided. You do not have to complete the application in one sitting. You are encouraged to click save frequently when entering information.
- **Other than the supporting evidence fields, the application requires that you submit specific, whole numbers. No decimals, text, or hyphens will be accepted in these numerical fields.**
- Applicants will be allowed to upload 1 PDF document consisting of the items below. **Applicants should save their application frequently before uploading the PDF to ensure no loss of data entered.** The PDF should include their CV and any evidence that has not already been submitted through the completion of the online application. This evidence should support the expertise and leadership sections of your application. **The contents of the PDF will only be used if clarification is needed for responses provided in the online application.**
 - A table of contents (if including more than your CV)
 - Current CV (required)
 - Evidence ***beyond what has already been listed*** in the online application to support the expertise and leadership sections of this application. In the PDF, please note which criteria is aligned with which pieces of documentation.
- Retired members seeking fellow status should complete the application considering their entire career at the time of and into retirement if some amount of work is continuing.

Applications not meeting the pre-specified AAPP service threshold of 35 points will not move forward for further consideration. AAPP attempts to be as thorough as possible in documenting volunteer service to AAPP and has increased and will continue to increase emphasis on this recordkeeping. Expertise

Applicants who hold the BCPP credential will acknowledge accordingly in the application and that status will be verified by AAPP.

Applicants who do not hold the BCPP credential must provide a 2,000 words or less descriptive narrative detailing how their experience demonstrates comparable knowledge and expertise in psychiatric pharmacy practice as aligned with the [BPS BCPP Examination Content Outline \(ECO\)](#).

The narrative will be submitted in the online application via an open text field. The 2,000 word limit will be enforced. The narrative should reflect the applicant's entire career and address the elements below. The applicant is encouraged to include detailed descriptions of specific activities, initiatives, programs, practice models, etc., with comments about their longevity and sustainability, along with supporting evidence provided in the 1 PDF allowed. Consider the following guidance as you author this narrative.

- Service or program description(s), including novelty within the health care system or institution, and basis for practice sustainability and/or growth (e.g., first at site, replication of practice, establishing a new team, new product launch)
- Recognition of practice or service (e.g., awards, acknowledgement)
- Demonstration of impact of practice or service through publication of achievements
- Research that has led to advancements in practice and/or process
- Novel educational initiatives that have led to advancement of practice and/or process
- Contribution to pharmacy services other than direct patient care (e.g., protocol development, formulary management, patient safety initiatives)
- Involvement with initiatives intended to have broad impact (e.g., health promotion initiatives)
- Consultative roles to international, national, or local industry, agencies, and groups
- Certification beyond BCPP
- Provide supporting documentation as part of the 1 PDF allowed (e.g., screenshots, websites, award certificates, publication citations, news articles)

Leadership

Applicants must complete the entire form for this section, as applicable, though achievements in each section are not required to achieve Fellow status.
